### **INVITATION FOR SUBMISSION OF TENDERS**

#### **IN OPEN PROCEDURE FOR PUBLIC PROCUREMENT OF LED LAMPS AND CONTROL AND MANAGEMENT SYSTEM FOR STREET LIGHT OF CITY OF KRALJEVO**

1. Type of Contracting authority: Public enterprise
2. Type of public procurement procedure: public procurement of supplies in the open procedure for award of a framework agreement.  
Framework agreement is to be awarded to the single supplier for a period of two years.
3. Type of contract: Supplies
4. Description of scope of procurement, name and designation in Common Procurement Vocabulary (CPV): Public procurement of LED lamps and control and management system for street light of City of Kraljevo; 315000000 - Lighting equipment and electric lamps
5. Right to participate is open to all legal and physical persons who fulfil the mandatory requirements from article 75. paragraph 1 of the PPL and additional requirements from article 76. paragraph 2 of the PPL, set in the tender documentation.
6. Fulfilment of mandatory requirements set in the articles 75. paragraph 1 and 76. of the PPL, tenderer is to prove in accordance with the article 77. of the PPL.

8. Tender submission deadline is 30 days from day of publication of this Invitation. Tenders are to be submitted to the address of the Contracting authority no later than 12,00 hours of the last day of tender submission deadline, that is 5<sup>th</sup> January 2017.  
Tenders are to be submitted in closed envelopes or box, by mail or to the Contracting authority directly, with following label:

Submission of electronic tenders is not allowed.

Tenders submitted after expiry of tender submission deadline are to be deemed late and will be, after tender opening session, returned unopen to the tenderers with notification that the submissions were late.

9. Tenderers shall not be authorised to tender for a variant within this procurement.
10. Tenders will be opened immediately after expiry of tender submission deadline, that is on 5<sup>th</sup> January 2017, beginning at 13:00 h, at the premises of the Contracting authority. Right to actively participate in the tender opening session is open to representatives of the tenderers.
